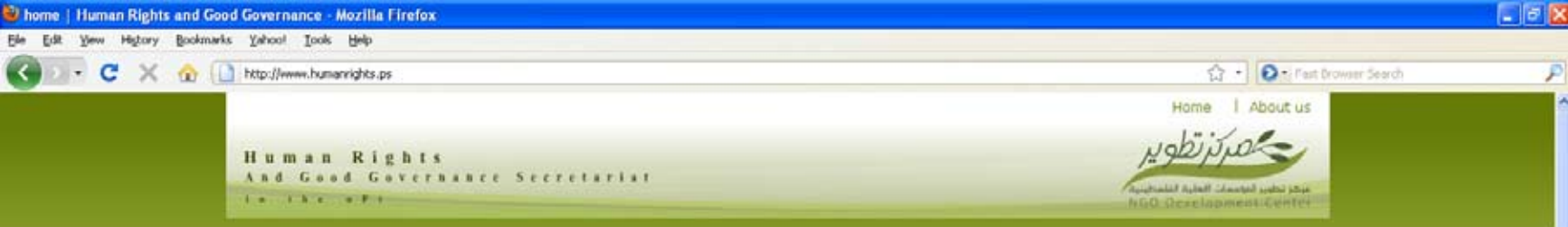

## HUMAN RIGHTS AND GOOD GOVERNANCE SECRETARIAT IN THE OPT

Welcome to [www.humanrights.ps](http://www.humanrights.ps), a website designed for NGOs, researchers, students, media and activists seeking information on human rights and good governance in the occupied Palestinian territory. The site aims to provide users with basic information on the work of various organizations focused on human rights and good governance in the oPt as well as funding and employment/research opportunities for those seeking to work/study in the area. In addition, a wide range of resources as well as a roster of experts is provided.

Although the site is maintained by the NGO Development Center (NDC), it is a fully interactive site that allows users to input reports, events, job opportunities, books, articles, photos and video of human rights and good governance issues/activities in the oPt. The site also has a blog wherein users can post and comment on articles of interest as well as a calendar to remind activists of upcoming events and serve as a tool for future planning of events.

### SITE CONTENTS:

**Funding Opportunities:** Under this section, users are provided with access to a range of reports under various topics affecting Palestinians in the oPt. Under each subcategory, a list of resources and experts can be found, including a list of member organizations working in each field.

**Studying and Working in the oPt:** Under this section, organizations can list any upcoming internships or job openings with organizations working on HR/GG. A list of Palestinian educational programs on these topics is also provided.

**Funding Opportunities:** A list of funding opportunities for organizations is contained in this section.

**Resources:** Under this section, a list of reports, international agreements and conventions as well as a list of experts by sector can be found.

**Gallery:** Relevant videos and photographs are included in this section.

**Calendar:** Users are provided an opportunity to list upcoming events so as to ensure greater visibility and participation.

**Blog:** Users are given the opportunity to blog and discuss various issues affecting HR/GG in the oPt.

**Highlights:** In this section, we highlight the newest reports/news.

The site is fully searchable and through the use of gadgets can be organized visually to suit a user's needs. Simply drag and reorganize the main page gadgets!

### USING THE SITE:

#### Create new account

Following a flash introduction, on the left-hand side of the screen, organizations, experts and users can create a new account. Users do not require an account to browse any of the information that is provided on the site; an account is required only to register organizations and experts and upload information to the site. Two types of accounts can be created: organization or expert. The latter will serve as a resource list for those seeking additional information on HR/GG in the oPt while the former will allow organizations to upload documents and contribute to the blog.

#### Create new content

Following registration, users (organizations and experts) will be given the opportunity to upload new content to the site. Content includes reports, books, articles, photos, videos, calendar events, agreements and internships. Organizations and experts will also be able to contribute to the [www.humanrights.ps](http://www.humanrights.ps) blog, as a means of debating and discussing various issues facing the HR/GG community.
